

# Call for Tender of Education program for Deep Sea Research by subsidizing sea voyages and operating heavy marine infrastructure purchased within the framework of The Mediterranean Sea Research Center of Israel – 2022-2023

The Mediterranean Sea Research Center of Israel (hereinafter "the Center"), is interested in the encouragement of advanced marine research by Israeli researchers in the Mediterranean, and the accessibility of the research infrastructures required to carry out the research.

The purpose of the support [granted by CHE] is to make the equipment and infrastructure available to researchers in Israel, who belong to the institutions of the Center, for the purpose of deep sea research, by subsidizing the costs of using the equipment and infrastructure. It should be emphasized that the support of CHE is intended for personal support of the researchers and is not intended for the institutions that are members of the Center.

The Mediterranean Sea Research Center of Israel hereby appeals to the Mediterranean researchers who are partners in the center, to submit applications for participation in the funding of marine research activities, using the existing marine infrastructures in the Center. These infrastructures include the heavy marine vessels and the monitoring stations in the marine observation buoys operated within the framework of the center.

#### **Conditions of Participation**

- 1. Each proposal will be submitted by a group of researchers from at least three partner institutions in the Center. The group of researchers must choose the leading institution for the purpose of submitting the application ("the leading institution").
- 2. The proposal will focus on actual marine research activity in the Mediterranean Sea.
- 3. The funding to be provided will cover the costs of renting the Center's marine infrastructure, sea voyages of a vessel suitable for the use of the requested equipment and other necessary costs related to the use of the equipment.
- 4. According to CHE guidelines, the funding will cover up to 80% of the equipment and sea time usage rates, and the researchers must complete the rest of the costs from their own sources.
- 5. The financed marine activity must be carried out in practice within one year of receiving the financing. Preference will be given to activities that are planned to be carried out within six months of the announcement of receiving the grant.
- 6. Priority will be given to researchers with defined research and funding plans to maximize the scientific potential of the requested marine activity.

The proposals will be examined by a judging committee for Mediterranean research, with the help of reviewers appointed by it as necessary.

The financing will be provided after the actual performance of the maritime activity and against the submission of a financial report signed by an authorized signatory of the leading institution. The receipt of financing is subject to administrative and budgetary approval in advance, to the income tax regulations and to the CHE guidelines.

To the extent that the funded activity results in scientific and other publications, credit will be given to the Mediterranean Sea Research Center of Israel according to a formula that will be coordinated with the Center, and its name will be mentioned in any media publication (including social media). The Center will be allowed to publish information about the research, in advance coordination with the winning researchers, on its website.

Applications must be submitted in English by e-mail to <u>merci@univ.haifa.ac.il</u> by 04/19/2023 at midnight. Offers submitted after this date will not be accepted.

The Center retains the right at any time, at its sole discretion and for any reason, to act as follows - to stop or cancel the tender and/or to change one of its conditions, including changing the conditions of participation and/or changing the deadline for submission and/or the amount of funding, and each participant waives any claim in respect thereto.

Applications must include:

- 1. The application form (Appendix No. 1) is signed by the authorized signatory of the leading institution.
- An opening page stating the title of the study, the details of the main researchers, the amount requested from the center and the total amount to cover the requested marine activity.
- 3. A document describing the goals of the research, the scientific and/or practical significance of the research, the participants in the research, the overall research plan and the marine activity for which the funding is requested. The document will include a summary of up to half a page, a detailed document of up to 2 pages of text. In addition, a list of introductions to the research plan and up to two pages of relevant illustrations can be included.
- 4. A detailed schedule for the requested marine activity.
- Budget breakdown for the requested activity, including breakdown of the researchers' participation and indication of additional sources for funding the continuation of the research following the marine activity.
