Every year, the ULF welcomes researchers from all over the world to submit their project proposals for funding. Applications are accepted from June 1 to the beginning of October. The Medical and Scientific Advisory Board's Grant Committee reviews the applications during October and November, and the applicants are informed of their decision in December. Applicants will be notified of their application status following the December Board Meeting.

Applications involving leukodystrophies research with budgets up to \$30,000 (plus up to 10% indirect costs) are welcome to apply. The ULF Medical and Scientific Advisory Board will review applications for scientific merit, feasibility, and likelihood to advance the field. Funding will be awarded by the end of December and extend for one year.

To apply: Download Application and submit Grant Application electronically to office@ulf.org.

Funded investigators will be invited to present their research at a future ULF Scientific Symposium in the Chicagoland area.

Deadline is **Tuesday, October 1, 2024**. All applicants will receive notification on the status of their submission by December 20, 2024.
